

March 7, 2023 Oliver Township board meeting minutes.

Seventeen members of the Oliver Township Fire Department toured Tower Automotive. Fire Chief Seley stated that Tower is very good at pointing out critical infrastructure items and safety equipment for emergencies. The next training tour will be at the new Dollar General store in town.
